Work group "International recognition and adoption of IGC-standards"

The IGC working group "International recognition and adoption of IGC-standards", headed by Prof. Dr. Ronald Gleich and Prof. Dr. Martin Tschandl, empirically investigates the degree of recognition as well as adoption of IGC-standards. Data is collected for both the perceived benefits and the spread of IGC-standards in practice. Thereby, the survey focuses on the following four different IGC-standards: Controller Mission Statement, Dictionary for Controllers, Controlling Process Model, and Controlling Process KPIs. In a first rollout in various countries can be broken down as follows:

In August 2015, the first working group meeting was held in Oestrich-Winkel. Thereby, the various subgroups came together to coordinate the content of the questionnaire. This questionnaire is currently being finalized in order to begin with the data collection in 2016. The empirical results will be published in various scientific and practice-relevant journals.

Controller Competence Model

We have finished the German version of IGC's competence model. With round about 250 pages it is the most comprehensive publication in the history of IGC. The publication will be available in German on November 20th. Right now we are working on the English translation and we plan to be on the market early February. As mentioned in the last issue of our newsletter, IGC members have the opportunity to order hard copies at a discount at Haufe before printing.
